



# PHASE III SBIR FAQs

## What kind of funding can be used on a Phase III SBIR?

SBIRs can use any type of funding except funding from the U.S. Small Business Administration (SBA) SBIR/STTR Program. No ceiling exists.

## What regulatory/statutory reference can be cited to prove the funding type is satisfactory?

The SBIR Program Policy Directive (4(c) and 7(g)(1)) explains which funding types are satisfactory.

## Is a novation agreement needed?

## Can you share your Bill of Sale, IP information, and other Phase II documentation?

Upon request, JJR can provide you with JJR's Bill of Sale, Intellectual Property Overview, and other Phase II documentation to support your due diligence process.

## Who retains data rights?

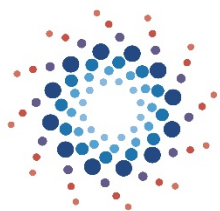
JJR's SBIR will not impede your data rights. Your platforms, your code, your data, etc., remain yours. Only the data JJR develops through its SBIR can be considered SBIR data.

## Who at JJR conducts Scope Validation to ensure my requirements can be worked under JJR's Phase III SBIR? Who reviews the Scope Validation?

Initial Scope Validation is conducted by your JJR POC. The resulting Scope Validation Report is then verified by the JJR Contracts Lead before coming to you for review.
